## ORDER

CS/1709/66

In exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with the order of the Government of India, Ministry of Food, Agriculture, Community Development and Cooperation (Department of Food) no. G. S. R. 906 dated the 9th June, 1966 and with the prior concurrence of the Central Government, the Administrator of Goa, Daman and Diu hereby makes the following Order namely:—

1. **Short title, extent and commencement.**— (1) This Order may be called «the Goa, Daman and Diu Controlled Commodities (Regulation of Distribution) Order, 1966.

(2) It extends to the whole of the Union Territory of Goa, Daman and Diu.

(3) It shall come into force on the 31st July, 1966.

2. **Definitions.**— In this Order, unless the context otherwise requires,—

(a) «Authorized Establishment» means catering establishment, hospitals, institutions, residential establishments, manufacturing establishments, mills, industries and any other establishments or class of establishments which the Government or the Director, Civil Supplies may declare to be establishments for the purpose of this Order;

(b) «Authorised fair price shop» means a shop run by a cooperative society or by a licensed dealer where controlled commodities are sold under the control of Government.

*Explanation*— On the commencement of this Order every cooperative society or dealer appointed or approved by the Directorate of Civil Supplies/Collector and the appointment or approval of which was in force immediately before such commencement shall be deemed to be an authorized fair price shop for the purposes of this Order.

(c) «Controlled commodities» means the commodities specified in the Schedule to this Order which are supplied by Government to any fair price shop or establishment for issue to the consumers, as well as such other commodities as may be notified by the Administrator from time to time and include milk (powder and condensed) imported into this Union Territory.

(d) «Establishment consumption» means all consumption of controlled commodities supplied by an establishment for consumption on the premises of the establishment or elsewhere;

(e) «Licensed dealer» means a dealer holding a valid licence under the Goa, Daman and Diu Sugar Dealer Licensing Order, 1963 and the Goa, Daman and Diu Foodgrains Dealers Licensing Order 1964, or an authorisation under this order.

(f) «Ration card» means a card or permit or other document issued or made available under the provisions of this Order by the Specified Authority, for obtaining supplies of controlled commodities and any card or permit or other document issued before the

commencement of this Order and on which controlled commodities were obtained immediately before such commencement.

(g) «Specified Authority» means the Director of Civil Supplies, Collector, Deputy Collector, the Collector Daman, the Civil Administrator, Diu or any other officer or person notified by Government in this behalf.

3. **Authorizations.**— The Government or the Specified Authority may issue from time to time to authorized fair price shop or any person having charge of an establishment, authorization to obtain from Government godowns or other agencies controlled commodities in accordance with the provisions of this Order.

4. **Security Deposit.**— Every authorized establishment or fair price shop before obtaining the authorization mentioned in foregoing paragraph, shall deposit with the Government a sum of Rs. 100/- if it is run by a Cooperative Society and Rs. 200/- in other cases, for the due performance of the conditions of the authorization or any direction that may be given by the Specified Authority and the sum so deposited or any part thereof may without prejudice to any other penalty be forfeited after giving to person concerned an opportunity of showing cause by the Government or the Specified Authority for contravention of any such conditions or directions.

5. **Powers to amend, suspend or cancel the authorizations.**— The Government or the Specified Authority may from time to time, whether at the request of the person concerned on its own motion after making such inquiry as may be deemed necessary, amend, suspend or cancel the authorization issued or deemed to be issued under this Order.

Provided, however, that before any authorization is cancelled, the person affected shall be given an opportunity of showing cause against such cancellation.

6. **Supply of controlled commodities.**— No authorized fair price shop or any other person shall sell or agree to sell or supply or agree to supply controlled commodities to any person except against a ration card and at such prices and at such quantity as may be specified by the Government or Director, Civil Supplies in this behalf from time to time.

*Explanation*— Supply of controlled commodities by the establishment for establishment consumption shall be made in accordance with the directions issued by the specified authority from time to time.

7. **Powers to issue ration card.**— (1) The Government or the specified authority or any other authority appointed by Government in this behalf, may issue or cause to be issued ration cards to any person or class of persons or to the public generally.

Provided that no such card shall be issued to any person unless such person or any other member of his family to whom the card is tendered on his behalf produces the necessary evidence as required by the specified authority.

(2) The specified authority or any other authority appointed by Government may at any time after making such inquiry as may be deemed necessary, add to, amend, suspend or cancel the ration cards.

Where any such card is suspended or cancelled, any person in possession of it should forthwith deliver it to the issuing authority.

Provided, however, that before any ration card is cancelled the person affected shall be given an opportunity of showing cause against such cancellation.

**8. Replacement of ration cards.**— Where any ration card is defaced, lost or destroyed, the Specified Authority on the request of the holder, after making such inquiry as he may think fit, may issue a new ration card in place thereof on payment of a fee of fifty paise. Every person to whom a new ration card has been issued shall, if he subsequently finds the lost one, forthwith return the latter to the issuing authority.

**9. Prohibitions on transfer of ration card.**— No person shall transfer to any other person a ration card issued to himself and no person shall use or dispose of or hold such card except under or in accordance with the provisions of this Order.

**10. Property in ration card.**— Every ration card or authorization issued under this Order shall be the property of the Government and the person to whom it is issued shall be responsible for its safe custody.

**11. Prohibition against applying for duplicate cards.**— No person shall—

(a) dishonestly apply for or receive a ration card if he knows or has reason to believe that his name is already included in any other card issued to any household.

(b) obtain a ration card by furnishing false information.

**12. Change of establishment.**— In the event of a change of the person in charge of an establishment, the specified authority may at the request of the new person in charge of such establishment, cancel the authorization issued in the name of persons previously in the charge of such establishment and issue a new one in place thereof on payment of a fee of fifty paise.

**13. Notice of absence.**— Every card holder shall notify the specified authority or any other person authorized in this behalf the absence from any household of any person or persons included in the card for more than one month. The notice shall be given within seven days from the date or expiry of the aforesaid period.

**14. Obligation to furnish returns and other particulars.**— Every authorized establishment or authorized fair price shop as the case may be shall furnish to the specified authority the returns and other particulars relating to his dealings in and stocks of controlled commodities in accordance with the directions that may be given by him.

**15. Powers to issue directions.**— (1) The Government or the Specified Authority in this behalf may issue directions providing for:—

(a) The conditions subject to which controlled commodities may be supplied/moved or obtained for household consumption or for establishment consumption or for any other purpose;

(b) The kind and quantity of controlled commodity to be issued for each purpose, and the price to be charged therefore.

(c) The manner in which ration cards may be used for obtaining controlled commodities including the conditions subject to which such cards may be registered with any authorized fair price shops.

(d) The period for which the ration cards shall be valid.

(e) The number of units allotted to any person or class of persons.

(f) The quantity of controlled commodities which a unit shall represent.

(g) The forms of authorizations to be issued and the conditions subject to which the authorized fair price shop or authorized establishment may obtain, move or supply controlled commodities.

(h) The registers that should be maintained and the returns that should be furnished.

(2) Every authorized fair price shop or other person to whom any order or direction is issued under any powers conferred by or under this Order shall comply with such order or direction.

**16. Powers to enter premises, inspect, search or seize ration card, ask question, require production of documents etc.**— (1) Any officer or person authorized by the Government or the Specified Authority may at all reasonable times enter any premises, inspect any ration card, stock of controlled commodities, books of account or other documents pertaining to dealings in controlled commodities and may in the course of such inspection search for and seize any such document or article in respect of which he has reason to believe that any provision made by or any direction issued in pursuance of this Order has been or is being or is attempted to be contravened.

(2) The provisions of section 102 and 103 to the Code of Criminal Procedure 1898 (5 of 1898) relating to search and seizure shall so far as may be, apply to searches and seizures under this clause.

THE ESSENTIAL COMMODITIES (AMENDMENT)  
CONTINUANCE ORDINANCE, 1969

No. 10 of 1969

Promulgated by the President in the Twentieth Year  
of the Republic of India.

An Ordinance to continue the Essential Commodities  
(Amendment) Act, 1964 for a further period.

Whereas a Bill to continue the Essential Commodities (Amendment) Act, 1964 for a further period has been introduced in Parliament but has not yet been passed;

And Whereas Parliament is not in session and the President is satisfied that circumstances exist which render it necessary for him to take immediate action to give effect to the provisions of the Bill;

Now, Therefore, in exercise of the powers conferred by clause (1) of article 123 of the Constitution, the President is pleased to promulgate the following Ordinance:—

1. **Short title and commencement.**—(1) This Ordinance may be called the Essential Commodities (Amendment) Continuance Ordinance, 1969.

(2) It shall come into force at once.

2. **Continuance of Act 47 of 1964.**—The duration of the Essential Commodities (Amendment) Act, 1964 is further extended for the period up to and including the 31st day of December, 1971 and accordingly, during the operation of this Ordinance, that Act shall have effect subject to the modification that in section 1 of that Act, in sub-section (3), for the words, figures and letters "the 31st day of December, 1969", the words, figures and letters "the 31st day of December, 1971" shall be substituted.

## REPORT OF THE COMMITTEE

1. I, the Chairman of the Select Committee to which the Bill to provide for the protection and improvement of Khar lands and the reclamation of tidal lands in the Union territory of Goa, Daman and Diu by the construction and maintenance of embankments and for certain other matters, was referred, having been authorised by the Committee to submit a report on their behalf, present this report with the Bill as amended by the Committee, annexed thereto.

2. The Bill was published in the Official Gazette on 16th August, 1969. It was introduced in the Legislative Assembly on 18th September, 1969. Motion for reference of the Bill to a Select Committee of the House was passed by the House on 7th October, 1969.

3. All Members of the Legislative Assembly were requested to send in their amendments and suggestions, if any, on or before 2nd February, 1970. Members of the public were also requested through a press note and also by an announcement made at the local station of the All India Radio to offer their views and send in their suggestions, if any, on or before 2nd February 1970. No amendments or suggestions were received from any member of the Legislative Assembly. Suggestions were, however, received from two members of the public. Besides some comments on the proposed measures had also appeared in the press. The relevant press cuttings as well as copies of the two suggestions as aforesaid were circulated to the members of the Committee for their consideration.

4. The Committee held 19 sittings in all and at some of the meetings, a technical expert namely an Executive Engineer, Shri U. Pisurlekar was also consulted. The first meeting was held on 17-1-1970. The provisions of the Bill were examined clause by clause and the comments appeared in the press and also the couple of suggestions received from the public were carefully examined and discussed in relation to the clauses concerned. Whenever it was felt necessary, changes were decided upon and incorporated in draft annexed to this report. The Committee finalised the amendments to be incorporated in the Bill and adopted the report in its meeting held on 1st February, 1971.

5. The Committee has also rearranged some of the clauses as they existed in the Bill as introduced.

6. The reasons for the important changes in the Bill are set out in the succeeding paragraphs.

*Clause 1(1).* — *Short title of the Act.* — The title of the Act is being changed from the Goa, Daman and Diu Khar Lands Act, 1969 to the Goa, Daman and Diu Khajan Lands Act, 1971. The term 'Khajan' is being

15. **Power to make rules.**— (1) The appropriate Government may, by notification, make rules for the purpose of carrying out the provisions of this Act.

(2) Every rule made by the Central Government under this Act shall be laid, as soon as may be after it is made, before each House of Parliament while it is in session, for a total period of thirty days which may be comprised in one session or in two or more successive sessions, and if, before the expiry of the session immediately following the session or the successive sessions aforesaid, both Houses agree in making any modification in the rule or both Houses agree that the rule should not be made, the rule shall, thereafter, have effect only in such modified form or be of no effect, as the case may be; so, however, that any such modification or annulment shall be without prejudice to the validity of anything previously done under that rule.

In exercise of the powers conferred on me under clause 15 read with Clause 2 (g) of Goa, Daman and Diu (Regulation of Distribution) Order, 1966, Director of Civil Supplies and Price Control, Panaji hereby directs, all the fair price shops run by Societies/Authorised retail dealers shall adhere to the instruction appended below:

1. They shall observe official timings strictly (9 a. m. to 1 p. m., 3 p. m. to 7 p. m.) while running the retail outlets excluding weekly holidays in a week.
2. The outlets shall not remain closed on working days due to the absence of the licensee where controlled commodities are sold under the Control of Government. In case the licensee has to proceed on leave, he should intimate the Mamlatdar of Taluka jurisdiction in advance. The Mamlatdar is competent to grant leave upto 3 days. In case, if the licensee wanting leave beyond 3 days, the Mamlatdar shall make alternative arrangement for distribution of Controlled Commodities. A suitable notice for card holders should be displayed on the PDS outlet.
3. The licensee shall ensure that ration card register is complete upto date and tallies with the Master Register Maintained in Mamlatdar's Office/Talathis Office.
4. The Complaint book shall be kept in each F. P. Shop clearly visible and within reach of the Consumer. The books viz. ration card register, stock register, daily sales register, visit book and complaint book should be page numbered and opened after obtaining the initials of the area Inspector. It will be checked by the Director of Civil Supplies/Dy. Director of Civil Supplies/Mamlatdar of the Taluka on his visits. The complaints should be promptly attended to.

5. The licensee shall display a stock board with all columns complete. Information regarding availability of specified articles shall be up dated daily.

6. The licensee shall not change or alter the premises without prior approval of Director of Civil Supplies and Price Control, Panaji. If he commits an irregularity in this regard, the authorization issued to fair price shop is liable to be cancelled.

7. The licensee shall maintain upto date accounts, cash memos issued should bear the name of consumer as well as card number, number of persons, name of wado etc. Items not taken by the consumers should not be recorded in the ration card.

8. Every licensee shall take adequate measures to ensure that controlled commodities stored by him are maintained in proper condition and that the damages of Controlled Commodities due to ground moisture, rain, insects, rodents, bird, fire and such other causes are avoided. Suitable dunnage shall be used to avoid damage from ground moisture and Controlled Commodities, shall be fumigated, with chemicals approved for the purpose by persons who have under gone practical training in that regard. The licensee shall also ensure that fertilizers, insecticides and poisonous chemicals likely to contaminate Controlled Commodities are not stored along with Controlled Commodities in the same godown or immediate juxta position of Controlled Commodities.
