Subject: Allocation of foodgrains under Welfare Institutions and Hostels Scheme - review thereof.

Respected Sir / Madam.

I am directed to say that Department of Food & Public Distribution has been making allocation of foodgrain to States/UTs for Welfare Institutions and SC/ST/OBC Hostels in terms of its Scheme "Allocation of Foodgrain under Welfare Institutions & Hostels Scheme" that has been revamped with effect from 01.09.2017 and subsequently reviewed on 19.03.2019. Now, in continuation of the schematic document dated 01.09.2017 (copy enclosed), it has been decided with the approval of the Competent Authority to make allocation of foodgrain under the Scheme beyond 2019-20 as well. The following has further been decided with effect from 1st April, 2020:

- 1. The allocation of foodgrain under "Allocation of Foodgrain under Welfare Institutions & Hostels Scheme" will be made to States/UTs in respect of Welfare Institutions & SC/ST/OBC Hostels that are aided/sponsored by States/UTs in addition to Welfare Institutions & SC/ST/OBC Hostels owned/run by State Govts/UT Admns or Administrative Ministries of Government of India;
- 2. Institutions/hostels should be vetted/recognized by State Govt's/UT Admn's line Departments namely Social Justice/Social Welfare/Tribal Departments, as the case may be and these must be receiving assistance from States Governments for their operation:
- 3. Hostels/institutions should not charge any fee from the beneficiaries/inmates for food;
- 4. As per existing guidelines, in case of hostels, 2/3rd hostellers should belong to SC/ST/OBC category, however, all the hostellers of such hostels will be eligible to receive foodgrains;
- 5. The allocation of foodgrain under the Scheme will be subject to uploading of the details of beneficiary institutions and hostels complete in all respects in the **prescribed proforma** enclosed, by the States/UTs on their respective portals;
- 6. The nature of management of the hostel/institution along with number of inmates in the respective hostel/institution should invariably be mentioned in the proposal:
- 7. The proposals under the Scheme complete in all respects should be sent to this Department well in time, i.e. at least one month in advance of the half year for which allocation is requested:

- 8. Accounts of such hostels/institutions would be available for audit by Indian Audit and Accounts Department as per GFR 316;
- 9. The proposal for allocation of foodgrain to such hostels/institutions may be routed through Central Govt line Ministries/Departments namely Social Justice / Tribal Affairs;
- 10. Other terms and conditions as mentioned in the schematic document dated 1-Sept-2017 will remain the same.
