**Sub : Allocation of Ration quota for the month of August, 2025.**

The ration card holders and the beneficiaries in the State are allotted following quota during the month of August, 2025 under National Food Security Act, 2013 Antyodaya Anna Yojana and Priority Household (AAY and PHH)(Fortified Rice), Tide Over (APL)(Fortified Rice), Tide Over Wheat and Welfare Institution Scheme (Fortified Rice) as under :
