**Sub : Allocation of Ration quota for the month of June' 2026.**

The ration card holders and the beneficiaries in the State are allotted following quota of foodgrains for the month of June' 2026 under National Food Security Act, 2013 (Antyodaya Anna Yojana and Priority Household), Tide Over (APL) and Welfare Institution Scheme:-


